Warwickshire Legal Services provide legal advice to the Police and Crime Commissioner and Office, in a Service Level Agreement let under the Goods and Services Act 1970. The agreement will begin on 1 April 2022 and will remain in force until 31 May 2025. It may be terminated by either party giving the other party at least 12 months' notice in writing to expire on 31 March in any year.
